- Actions to prevent asylum seekers and migrants from becoming victims of criminal networks engaged in human trafficking and smuggling;
- Voluntary return from the countries of transit to the countries of origin;
- Integration;
- Support to refugee-hosting communities;
- Development-related actions;
- Resettlement.
