2 Identification/travel documents

If the decision stated that you needed to provide identity documents when you were granted your previous residence permit, then you must make sure you deliver these now. Please note: If, by attempting to obtain such identity documents, you put yourself in danger, you do not need to provide them.

If you have managed to obtain the documents we have requested, you must bring the following along when you submit your application:

- The identity documents you were asked to obtain, for instance your passport. Remember that all documents must be valid and that it is the original documents that must be presented. You cannot submit copies.
- A statement of when, where and how you obtained the identity documents/passport. The statement must be in Norwegian or English.

If you have **not** managed to obtain the documents we asked for, you must bring the following along when you submit your application:

- A written statement about why you have not managed to obtain the documents we asked for. The statement should be written in Norwegian or English.
- Documentation that shows that you have attempted to obtain the documents and why you haven't managed to.
